- A Person may join the Dalhousie Fire Department as a junior firefighter upon reaching the age of 14.
- Junior Firefighters will require written permission from a parent or guardian to become a member of the Dalhousie Fire Department.
- Acceptance as a junior firefighter is subject to the discretion of the Fire Chief, Officers and Members of the Dalhousie Fire Department. Junior Firefighter status may be revoked at any time at the discretion of the Fire Chief. Junior Firefighters are subject to a six months probation period, which may be extended indefinitely at the discretion of the Fire Chief.
- Junior Firefighters will assist with clean up and returning apparatus and equipment back to service.
- Junior Firefighters shall not respond between the hours of 7:00 am and 4:00pm on regular school days. Junior firefighters shall not allow fire department issued communications equipment to disrupt classroom activities while attending school. Communications equipment shall be turned off when entering the classroom.
- Junior Firefighters may attend training exercises at the discretion of the Fire Chief, subject to the terms and conditions of the training organization
